name and surname, e-mail address, telephone number. Providing this personal data is completely voluntary. In the event of failure to provide them or providing incorrect data, the Administrator will not be able to respond to the information sent.

Legal basis for the processing of personal data

Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation) ("GDPR") - art. 6 sec. 1 letter a), c), d), f) of the GDPR.

Purpose of processing personal data

The administrator processes personal data for the purpose of:

provide answers to people who provide the Administrator with information via the online contact form and have given their consent in this regard;

fulfilling the obligations incumbent on the Administrator by law, e.g. to detect acts prohibited under the law or to prevent such acts;

protection of the vital interests of data subjects or another natural person in a situation that threatens these interests;

pursuing the Administrator's legitimate interests, such as:

ensuring effective communication with the market environment, in particular with people who contact us;

ensuring that our website is used in accordance with the law and good practices, including establishing, investigating or defending claims Administrator;

improving the quality and transparency of the website operation; and

maintaining efficient business management and relations with the group's environment capital of the Administrator.

Period of personal data storage

Personal data is always stored or processed to the extent necessary for implementation of the given purpose of their processing.

In case of:

a) your consent will be stored or processed until you notify us about its withdrawal or limitation;

b) the legal obligation incumbent on the Administrator (in Polish or EU law) will be stored or processed in accordance with such legal obligation;

c) necessary to protect the vital interests of the data subject or of another person physical data will be stored or processed until the emergency ceases for these vital interests, legally protected goods;

d) the legitimate interests pursued by the Administrator will be stored or processed until objection is raised or completed the pursuit of such an interest.

The rights of persons whose personal data are processed by the Administrator

A. The right to access personal data - anyone can find out whether his data personal data are stored by the Administrator, and if so, how.

B. The right to rectify personal data - anyone can rectify, modify, update personal data concerning him.

C. The right to be forgotten - the Administrator deletes personal data and ceases them processed if these data are no longer necessary for the purpose of their collection or processing, if the data subject withdraws his consent to them
